I agree to abide by any decision of a race official, including law enforcement officials, relative to any aspect of my participation in this event, including the right of any official to deny or suspend my participation for any reason whatsoever. I attest that I have read the rules of the race and agree to abide by them, including those prohibiting bicycles, skateboards, baby joggers/strollers (excluding the dedicated 5K Stroller Roll), roller skates or inline skates, animals, and personal music players are not allowed in any race. As a condition to participating in a GDCA event, I assume all risks associated with or relating to participation, including, but not limited to: falls; potentially injurious physical contact with other participants, volunteers, race personnel, contract service providers, employees, spectators or objects that will or may be located on the race course, such as barricades or other traffic or crowd control devices, timing mats, aid station tables, or service vehicles; hazardous conditions of the roadway, shoulders and sidewalks or other public areas on and around the race course or pre or post-race event venues; the effects of weather on participants and/or the course (including high or low temperatures, rain or wind); any acts of violence that occur at or during the event; and the potential of contracting a communicable disease, including 2019 Novel Coronavirus Disease (COVID-19), associated with contact, or being in close proximity, with other participants, volunteers, race personnel, contract service providers, employees, and spectators. I understand and acknowledge that the GDCA cannot fully protect me from or against the risks associated with this event, including the possible exposure to communicable or infectious diseases.
