I agree to abide by any decision of a race official, including law enforcement officials, relative to any aspect of my participation in this event, including the right of any official to deny or suspend my participation for any reason whatsoever. I attest that I have read the race rules and agree to abide by them.

I understand and acknowledge that the Gasparilla Distance Classic Association ("GDCA") cannot fully protect me from or against the risks associated with this event, including the possible exposure to communicable or infectious diseases.

I also understand that in the event any or all of the Publix Gasparilla Distance Classic Race Weekend events cannot be held as scheduled because of a public health event, an act of God, or circumstances beyond GDCA's control, including the issuance of any executive, county, municipal or judicial order, law or rule, the Publix Gasparilla Distance Classic Race Events will be canceled and I will be entitled to a partial entry fee refund or partial entry fee deferral to 2027, according to the Gasparilla Distance Classic Association's Event Cancellation Refund & Deferral Policy.

I grant the Released Parties permission to use my photographs, motion pictures, images, likeness, recordings, or any other record of this event for any legitimate purposes, including for commercial purposes, without compensation.

I agree to drug testing in accordance with the USA Track and Field and IAAF Rule 144 if I place in the Top 25 overall men and women. I also hereby consent to permit emergency treatment in the event of injury or illness. The Gasparilla Distance Classic Association reserves the right to reject entry for any reason.

I understand that all people under 18 years of age must have the written consent of their parents or legal guardians to compete in the abovementioned events. I, the undersigned parent or guardian, hereby consent to the applicant's participation and waive and release all rights and claims for damages as more fully set forth above.
